- Paver Thaw can be applied to surfaces several hours prior to the anticipated formation of ice to maximize ice melting and minimize ice damages.
- Power lines, telephone and TV cables, and emergency communication lines can be deiced directly from line service trucks. Trees suffering from the breaking weight of sudden ice storms can be sprayed with Paver Thaw and ice is instantly melted, removing the threat of fallen limbs breaking power lines.
- Paver Thaw is idea for concrete forms, scaffolding, ladders, steps and ramps where ice removal is critical to workers safety. Ideal where salts or crystals have limited application and leave patches of salts or crystals that track and roll.
- Rain gutters, ice dams, and downspouts can be de-iced quickly from the ground, with a long spray attachment, eliminating structural damage to soffits and roofs during long cold spells and ice storms.
- Landscapers can use Paver Thaw to quickly and safely remove ice from young or transplanted shrubs and trees to eliminate branch splitting and breakage. Paver Thaw will not harm grass or vegetation.
